This document is a summary of Chevin Housing Association's definition and policy with regard to racial harassment.

Copies of the full policy and procedure for dealing with racial harassment, as part of our general policy and procedure on anti-social behaviour, are available to any person on request.

Racial Harassment

The Association is committed to achieving and maintaining a peaceful and secure environment for all our residents. We adopt a zero tolerance mentality towards racism and racial harassment. With regard to a definition of a racist incident, the Association utilises the Macpherson report, 1999, recommendation 12 which states:-

“A racist incident is an incident which is perceived to be racist by the victim or by any other person”.

The Association adopts a victim centred approach for report taking and investigation which will ensure that any racial motivation is fully considered while the incident is being investigated.

It is our policy that we:-

- Encourage reporting
- Support victims
- Take action against the perpetrators

Any complaint regarding racial harassment can be reported via the telephone, in writing, home visits, by email or by visiting a local office. You can also utilise any other agency to act on your behalf. We can offer full translation services to you if English is not your first language.

All complaints are recorded and contact with the complainant will be made, wherever possible, by a member of the Anti-social Behaviour Team within one working day.

At the visit, details regarding the incident/s will be taken and following contact with the perpetrator, a plan of action will then be agreed.

Areas that will be covered include timescales for action, possible legal remedies, how we can assist in improving house security, local support contacts and your possible need to be rehoused. You will also be given an information pack regarding local and nationally based support.

The Association works within the confines of the law as it affects you and us in relation to your tenancy agreement. Racist behaviour is a criminal act and in such cases the police should be involved. If you have been the victim of assault, criminal damage, intimidation, threats, harassment, offensive letters or nuisance telephone calls then you should consider reporting these incidents to the police. The Association has a policy of reporting all racist incidents to the police but we will retain the anonymity of any victim if they so wish. It is important to note that any criminal convictions the police obtain against a perpetrator may be used as evidence in a civil court of law if we seek to attempt to obtain an injunction, eviction order or anti-social behaviour order.

The Association continually monitors its performance with respect to dealing with allegations of racial harassment and as part of this process victims will be asked specific questions about how their complaint was dealt with once the case is closed. We therefore encourage you to take part in such surveys if you have been the victim of racism.

The Association will not tolerate racism. Please help us to eradicate this problem by reporting incidents to us as soon as they occur. We will deal with your complaint seriously, respectfully and in confidence. Should you be unhappy with the service we have provided the Association's complaints procedure should be utilised in order that your grievance can be fully investigated.
